The OSHA forklift training standard is in the OSHA general industry regulations at 29 CFR 1910.178(l)- Powered industrial truck operator training. If you are a forklift operator you must: (1) be competent to safely operate the particular forklift you will use, and (2) successfully complete the training required by the standard.

The OSHA powered industrial truck standard [29 CFR 1910.178] lists a number of conditions under which a forklift must be removed from service. If the operator notes these conditions while driving, the operator must stop, park the vehicle and get assistance.
